MEMORANDUM OF UNDERSTANDING

between

St. Joseph's College (Autonomous), Tiruchirappalli-620 002

and

Cauvery College for Women (Autonomous), Tiruchirappalli-620 018

This MoU is entered on this 08th day of March 2023 between Department of Hindi, St. Joseph's College (Autonomous), Tiruchirappalli and Department of Hindi, Cauvery College for Women (Autonomous), Tiruchirappalli.

The essence of this MoU is to establish accord and exchange various resources available like technical knowledge, literature in the form of books, periodicals, journals, with St. Joseph's College, Tiruchirappalli-620 002 and Cauvery College for Women, Tiruchirappalli-620 018.

Both parties agree to encourage the following exchange activities based on their respective academic and educational needs.

- i. Exchange of students
- ii. Faculty as resource persons
- iii. Joint Conferences/Seminars/Workshops
- iv. Other academic exchange as may be agreed from time to time

The implementation of each exchange program referred above will follow the guidelines established on mutual agreement by both parties. Efforts will be made by both parties to find financial resources for carrying out the activities listed above.


Nothing shall diminish the full autonomy of either institution nor will any constraints be imposed by either upon the other in carrying out the agreement.

This agreement shall be in force for a period offive years from the date of signing and is subject to revision or modification by mutual agreement. It is also understood that this agreement may serve as the basis for specific agreements to be developed at a later date. It is further understood that either institution may terminate the agreement at any time, upon one year written notification to the partner institution, although such action will only be taken after mutual consultation in order to avoid any possible inconvenience to either party.

IN WITNESS WHEREOF, the Parties have executed this MoUon this 8thday of March, 2023and represent that they approve, accept and agree to the terms contained therein.


