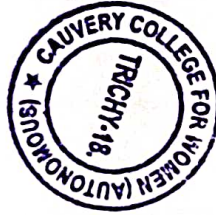

5	Introduction of Value added courses	Following the discussion with the heads of departments, Deans, controller of examinations with the principal has introduced value-added courses. These courses aim to provide students with additional skills and knowledge, enhancing their academic experience. A total of 91 skill-oriented courses have been introduced, including specialized courses offered by various departments. Moreover, extracurricular activities such as sports, yoga, and the institutional innovation council have also been incorporated into the value-added courses. It is mandatory for each student to enroll in at least one course for each academic year, ensuring a well-rounded education that goes beyond the core curriculum.
6	Allocation of seed money fund	The Research Advisory Committee received a total of 64 research proposals from faculty members across various departments. To ensure a fair evaluation process, selected members of the BOS. were assigned to evaluate these proposals. The proposals with the highest scores were selected for funding. For departments such as Physics, Chemistry, Microbiology, and Biotechnology, an allocation of Rs. 15,000 was sanctioned, while the remaining departments were granted Rs. 10,000. In total, Rs. 1,70,000 has been sanctioned for research funding this year. This demonstrates the college's commitment to supporting and promoting research activities among its faculty members.

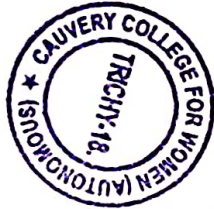

2	Proposal for NAAC sponsored seminar	After discussion in the meeting, we promptly submitted our proposal and were fortunate enough to secure sponsorship from the NAAC for our seminar. A generous sum of Rs. 30,000 was sanctioned by the NAAC to support the event, which we aptly titled : "Two day virtual national seminar on fostering global competence among higher education institutions through technology" organized on 90-06-2022 and 10-06-2022. A comprehensive report to NAAC.
3	Evaluation of Semester results	For the even semester 2021-22, the examination results were published on 20-05-2022 the website after the completion of examination within 15 days, the exam results were also published by the COE (Controller of Examinations) section.
4	Purchasing of Plagiarism software	Following the meeting discussions and thorough evaluations of various quotations, we made the decision to purchase the TURNITIN plagiarism software for Rs. 63,700. This software is currently in the process of being implemented for use by both faculty members and students. In order to ensure accessibility, the plagiarism software has been made available in the library for faculty members and students to utilize. As of now, nearly 20

Presently, the PFMS portal is being utilized for the DST- curie project, with the project assistant responsible for its management and maintenance. This development ensures efficient and secure financial management for the curie project through the PFMS portal.
