MINUTES

The meeting commenced with the prayer. The Principal of the institution, Dr. V. Sujatha welcomed the gathering and initiated the proceedings of the Governing Body.

Confirmation of the Minutes of the previous meeting & Action Taken Report based on the Ninth Meeting of the Governing Body

The minutes of the Ninth meeting of the Governing Body held on 21st February, 2024 were read and confirmed. The Action Taken Report based on the discussions of the previous meeting were recorded and confirmed.

Mr. S. Gopal, President, College Governing Council, denoting the increase in pass percentage of the third year UG and PG students, which is higher than the first year UG and PG results, inquired the reason behind it.

The Principal of the college **Dr. Mrs. V. Sujatha** explained the struggle faced by the students due to the change of the medium from Tamil to English in the first year. Referring to the strict insistence by the College to write the answers in English in the exam, she also pointed out the gradual development of the students in the three years and its reflection in their results.

Dr. G. Gopinath, University Representative, enquired about the B.Sc Cs with Cognitive Systems Programme offered by the college.

The Principal of the college Dr. Mrs. V. Sujatha mentioned the uniqueness of the programme with its tie-up with TCS. Referring to the MOU signed by the College, she added about the 75 percent of students who are likely to receive their placements from TCS. She stated the awareness of the parents about its equivalence, and their interest to join the course because of its integration with IT industry and relevant syllabus.

Mr. N. Ramesh, Managing Director, Vethaa Milk Industry, Trichy, offered to connect all the products of the Company to e Mart Cauvery for sales. He also invited the students of the college for both training and internship in Vethaa Milk Industry. Since many companies use software integrated with Tally, he urged the college to offer a course on it. He recommended to strengthen the connection of alumnae and their guidance.

The Principal of the college, Dr. Mrs. V. Sujatha, referred to the Advanced Tally Course offered to Commerce graduates in the fourth semester. She registered the efforts made by the college to update the syllabus on time, as per the recommendations of the Board of Studies members appointed from various parts of Tamil Nadu, to meet industrial requirements.

Mr. R. Saranath, Treasurer of the College Governing Council, inquired about the credits awarded for journal publications and their inclusion in students' academic scores. He insisted the students to take up case studies on both the success and failure stories of industries and emphasized the need to evaluate their outcomes.

The Principal of the college, Dr. Mrs. V. Sujatha, assured that the students of Management, Commerce, Cognitive Systems, and other related fields would be involved in case studies. She also referred to the Startup Acceleration Course, the first of its kind, introduced in the academic year 2024-25 as part of the curriculum, with 3 credits. She added that it is offered in the fourth semester for Science graduates and the fifth semester for Arts graduates, aiming to foster students' interest in entrepreneurship.

Mr. R. Saranath, Treasurer of the College Governing Council, has requested the invitation of experts to orient students from Computer Science and other majors about various fields in the IT industry where knowledge of programming languages is not required.

Dr. Mrs. V. Sujatha read out the activities planned for the Ruby Jubilee Celebrations 2024 of the college and seeked approval from the management.
