This Memorandum of Understanding is made 1st Day of August of 2024

Between

M/s. Sujatha, M.Com., M.Phil., PhD which term shall mean and include unless repugnant to the context the Authorities, Administrators and Assigns.

And

M/s. Trichy SRM Medical College Hospital & Research Centre, (hereinafter referred to as "TSRMMCHRC"), having office at Irungalur Village & Post, Mannachanallur Taluk, Tiruchirappalli 621 105, Tamil Nadu, a unit of M/s. SRM Institute of Medical & Technical Research (Educational Trust), represented by its Dean, Dr. S. Revathy, MD, DGO, DNB., which expression shall unless repugnant to the context means and include its Successors and Assigns.

1. PURPOSE

The purpose of this MoU is to define the basis for collaboration between **CCW** and **TSRMMCHRC** for Internship, Industrial Visit and Project Work of B.Sc., Nutrition & Dietetics and M.Sc., Food Service Management & Dietetics Degree Programme.

Scope of the MoU will include but will not be limited to the following:

- a. **Student Internship and Performance Assessment:** **TSRMMCHRC** will accept limited number of students each year for internship for a duration of **15 days** to train them in industrial processes. There will be no obligation on part of **TSRMMCHRC** to pay remuneration to the students at the time of internship or to guarantee them employment on completion of internship. **CCW** agrees to depute a faculty to monitor periodically the progress of students and ensure their disciplinary behavior, meeting with industry norms and regulations. **TSRMMCHRC** will carry out assessment of student's performance and provide an attendance cum performance review report and Internship completion certificate.
- b. **Industrial Visit:** **TSRMMCHRC** will accept limited number of students from **CCW** each year for industrial visit to observe the functional areas of **TSRMMCHRC** such as Dietary Department, Biochemistry Laboratory, In-patient wards and Outpatient Diet counselling area.
- c. **Project Work:** **TSRMMCHRC** will allow students of **CCW** for data collection for project work shall obtain prior approval from **TSRMMCHRC**. The data which will be provided by **TSRMMCHRC** can be of primary or secondary data.

2. TERM AND TERMINATION

This MoU shall be valid for a period of **3 Years**. Thereafter **CCW** and **TSRMMCHRC** may mutually agree to extend this MoU in writing.

Parties may terminate this MoU upon giving thirty (**30**) days written notice to the other Party for breach of any material provision of this MoU, and where there is failure to correct such breach within the said notice period.

3. OTHER GENERAL TERMS

It is agreed between the Parties that this is an arrangement between both the Parties and shall not represent to third parties that they are the agent of the other. Nothing in this MoU shall be construed to grant either Party the right to make commitments of any kind for or on behalf of the other Party without prior written consent of the other Party.

4. CONFIDENTIALITY AND IPR

All commercial, process, data and information shall be kept confidential by both the parties. Publication of any results in public domain shall only be after mutual written consent. Intellectual property rights arising from joint collaborative work shall be shared mutually based on prior agreement for specific projects.

This MoU shall be governed and construed in accordance with the laws of Republic of India.

Disputes, if any, arising out of this MoU will be mutually discussed and settled without any obligation on either Party, failing which, the disputes shall be referred to Arbitration of two Arbitrators, one each to be appointed by the Parties and a third Arbitrator shall be appointed by the two Arbitrators appointed by the Parties, who shall act as 'Presiding Arbitrator'. The Arbitration proceedings shall be in accordance with the provisions of Arbitration and Conciliation Act, 1996 and Rules framed there under from time to time. The place of Arbitration shall be at Tiruchirappalli and all Arbitration proceedings shall be conducted in English language and governed by the above said Act and Rules and in Indian Laws.

In witness thereof, the Parties have caused this MoU to be signed in their respective names as of date first mentioned above.





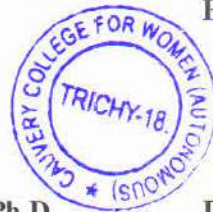
